In the above context, kindly furnish immediately the DAR/Vigilance position, in the enclosed format, of the Group'B' officers mentioned therein.

- 2. While furnishing DAR/Vigilance position, mere statements like, chargesheet has been issued, CBI case/criminal case is pending, etc will not do. If any departmental chargesheet has been issued or any chargesheet arising out of any investigation done by the CBI or Civil Police has been filed before any Court of Law, it may be ensured that the dates when such chargesheets have been issued/filed are invariably indicated. If any punishment(s) have been imposed, details thereof and the operative period, NIP dates and corresponding chargesheet date in each case, may be indicated precisely. Copies of chargesheets/NIPs may also be invariably furnished.
- 3. If there is any subsequent change in the above DAR/Vigilance position, be it due to issue of any departmental/criminal charge-sheet, imposition of punishments, etc., in the meanwhile, it should be advised to this office promptly so that the same could be placed before the DPC in time for consideration. Further, if any officer has ceased to be in service in the meanwhile, for whatever reasons, the same should also be brought to the notice of this office promptly. These actions taken in time will help reduce the scope of review DPC.
- 4. If any officer is on deputation to any other organisation/unit, it will be the responsibility of the parent Railway where the officer is holding his permanent lien, to collect the DAR/Vigilance position from that organisation/unit and include the same in their DAR/Vigilance position before sending it to this office as per the instructions issued under Board's D.O. letter No. E(GP)2009/1/59 dated 5.10.2009. A mere statement that it may be collected by Board's office from the concerned organisation/unit will not do.
