In the above context, kindly furnish DAR/Vigilance position for the last 10 years, in the enclosed format, in respect of the Group 'B' officer mentioned therein.


- 2. While furnishing DAR/Vigilance position, the following directions may be adhered to strictly in order to restrict avoidable delays in the DPC process:-
- i) The Zonal Railways should keep a track on these officers so that any changes that can take place subsequently w.r.t. issue of any chargesheet, imposition of punishment, exoneration/dropping of charges, etc. can be brought to the notice of this office promptly. It will help reduce the scope of review significantly.
- ii) Further, if an officer ceases to be in service subsequently (other than by superannuation), the same may be brought to the notice of this office immediately. In that case, the DPC can provide an Extended Panel, if necessary. It will also help reduce the scope of review significantly.
- iii) If an officer is under suspension, the date from which he is under suspension may be indicated precisely in column (7) of the enclosed format. A copy of the suspension order may also be sent.
- iv) In any pending departmental/criminal proceedings, the date of issue of departmental chargesheet or the date of filing of the criminal chargesheet in the court of law should be indicated precisely in column (6) of the enclosed format. A mere statement that a departmental/criminal case is pending will not do.
- v) Where a case has been finalized after imposing a punishment, the details thereof, period of its operation, NIP date and the date of the corresponding chargesheet should be mentioned precisely in column (9) of the enclosed format.
- vi) Where the punishment imposed is still in currency, the details thereof, period of its operation, NIP date and the date of the corresponding chargesheet should be mentioned precisely in column (8) of the enclosed format. Copies of chargesheet and NIP should also be sent.



- vii) Other relevant information, such as, whether the officer is working in Sr. Scale and if so, from which date, etc. may be provided in column (10) of the enclosed format.
- viii) In terms of Board's letter No. E(GP)2009/1/59 dated 5.10.2009, it is the responsibility of the concerned Zonal Railways to collect DAR/Vigilance position in respect of the officers who are on deputation to some other organizations. A mere statement that it may be collected by the Board's office from the concerned organizations will not do.
