Minutes of the Extraordinary General Body Meeting held during IRAS DAY-2015 celebrations at Manekshaw Centre, New Delhi on 28th November, 2015

During the Extraordinary General Body meeting of IRAS Association held on 28th November, 2015 at Manekshaw Centre, New Delhi, Shri P. V. Vaidialingam, Secretary General of IRAS Association welcomed all IRAS officers and highlighted the achievements made by the association and also some of the issues dealt with by the IRAS Association in the past.

2. Shri Sanjay Upreti, EDF/C/RB conducted the proceedings of Extraordinary General Body meeting.  - (iv) Shri Neeraj Kumar, DF(X)I as Joint Secretary (I)
 - (v) Shri Manoj Kumar Dubey, EDF(PPP) as Joint Secretary (II)
 - (vi) Shri Dhrubajyoti Sengupta, DyCAO/G/G/CR as Joint Secretary (III) (as an outside Delhi member)
 - (vii) Three Executive Members nominated and appointed to the council were Smt. Preeti Jha, FA&CAO/T/NR, Shri Vinayak Rao, FA&CAO/RWF/Bangalore, Shri Abhishek. Kumar, DyFA&CAO/WP-I/ECR.

5. It was also agreed by Voice Vote that the term of the Governing Council shall be two years from the date of the election.
