3. While approving the above, the ACC has also approved the following:

- Ministry of Railways shall adopt procedure analogous to DPC from the next empanelment year with regard to the recommendations pertaining to the extended panel for persons who are going to retire in the panel year, and restrict the panel size accordingly.
- From the next year onwards, Railway Board shall comply with DOPT's instructions whereby the panel year would be calendar year and not financial year.
- Railway Board to submit a concept note on feasibility of assessing the suitability and leadership abilities of officers to be posted as GM/DRM through an interaction process or any other objective means rather than solely relying on APARs for facilitating better management of outcomes.
